- **3.** One paid CL for each month for 8 months.
- **4.** For Nurse Rs. 750/- for attended days only.
- **5.** Teacher/staff will not be entitled for pay, if remains absent on working day. In case of absence from duty, payment will be calculated on pro rata basis.
- **6.** She / He would be engaged till such time the regular teacher/staff joins or the end of the academic session / the purpose for which the appointment made is served, whichever is earlier.
- **7.** Working hours shall be same as that of regular teacher.
- **8.** Teachers engaged on contractual basis, will have no claim or right for appointment on a regular basis nor they will be of part of cadre of teachers of Kendriya Vidyalaya Sangathan.
